- Provide accurate information about and interpretation of the Matchless Mine, the NMHFM, and the surrounding area
- Respond to guest inquiries in a courteous, professional, and timely manner
- Lead guest activities, such as gold-panning
- Inform Curator of problems and issues regarding the site in a timely manner
- Inform the Curator or Operations Manager of problems and issues in a timely manner
- Enforce strict safety regulations
- Perform light maintenance duties
- Help prepare the site to open for the summer and close for the winter.
- Work toward continuous quality improvement
- Stay current with changing technology, including software and Point of Sale programs
- Uphold, support, and promote all company policies and procedures

Supervisory Responsibilities:

The Matchless Docent has no supervisory responsibilities.
